HOMESTEAD CREDIT

We would like to remind residents of an available property tax credit known as the Homestead Credit. This tax credit is funded by the State of Iowa for qualifying homeowners and is generally based on the first \$4,850.00 of Net Taxable value. To be eligible you must own and occupy the property as a homestead on July 1 of each year, declare residency in Iowa for income tax purposes and occupy the property for at least six months each year. Persons in the military or nursing homes who do not occupy the home are also eligible. Please contact the Woodbury County Assessor for more information at 712-279-6505.
